Sir,

I am directed to say that Central Deputation Reserve(CDR) of AGMUT Cadre is fixed 20% of the total senior duty post of AGMUT Cadre i.e. 112 posts as notified by the Department of Personnel & Training vide notification No. 16016/06/2008-AIS-II (A) dated 24<sup>th</sup> March, 2009. The Competent Authority has observed that the AGMUT Cadre is over utilising its Central Deputation Reserve(CDR) and therefore it has been decided to put a "cap" on CDR till the CDR of AGMUT Cadre comes down to 20% as prescribed in the above mentioned notification of DoPT.

All are informed that henceforth IFS officers of AGMUT Cadre will not be considered for the Central Deputation posts till the CDR of AGMUT Cadre comes down to 20%.
