**NOTIFICATION**

GSR No . . . . . In exercise of the powers conferred by sub-section (I) of section 3 of All India Services Act, 1951 (61 of 1951), read with rule 4 of the Indian Forest Service (Cadre) Rules, 1966, the Central Government, in consultation with the Government of **Manipur-Tripura** hereby makes the following regulations further to amend the Indian Forest Service (Fixation of Cadre Strength) Regulations, 1966. Namely:-

1. (i) These Regulations may be called the Indian Forest Service ( Fixation of Cadre Strength ) Second Amendment Regulations, 2002.  
(ii) They shall come into force on the date of their publication in the official Gazette.
2. In the Schedule to the Indian Forest Service (Fixation of Cadre Strength) Regulations, 1966, for the heading "**Manipur-Tripura**" and the entries occurring thereunder, the following shall be substituted, namely:-
