



NOTIFICATION



An officer who does not hand over charge at the end of the approved period of deputation will be immediately liable to disciplinary action and break-in-service beyond the approved date. The Accountant General is being instructed not to pay salary etc. for any period beyond the approved period of deputation.

The inter-cadre deputation is valid only for the period for which it is allowed by the Central Government and any extension in neither automatic nor should it be presumed. As such, the officer shall be entitled to draw salary, etc. in the State to which he/she has been deputed only for the period for which he/she has been allowed deputation by the Government of India. He/she shall not be entitled to draw salary etc. after expiry of the period of deputation.
