**Subject: Selection of IFS officers as faculty in the forestry training institutions under the Government of India-reg.**

Sir,

I am directed to say that Ministry of Environment & Forests (MoEF), Government of India under the Central Staffing Scheme of the Ministry for the IFS officers, appoint on central deputation tenure basis, IFS officers as teaching faculty in the Indira Gandhi National Forest Academy, Dehradun and forestry training colleges under the Directorate of Forest Education, Dehradun. In order to select the IFS officers who have real aptitude, competence and interest in teaching in the forestry training institutions, the following guidelines are issued:

- (a) The Director, IGNFA through constant interaction with the state officials shall shortlist the officers for appointment as faculty.
- (b) The short listed candidates shall be called to the IGNFA for a few days at the Government of India expenses to assess their aptitude and competence in teaching.
- (c) Such officers shall be assessed for their aptitude/competence in teaching by a committee.

2 The constitution of the committee will be as below:

<b>S. NO.</b>	<b>Designation</b>	
1.	Director, IGNFA	Chairman
2.	Addl. Director/Jt. Director, IGNFA	Member
3.	One Professor (to be nominated by Director, IGNFA for selection of Associate Professors)	Member
4.	Director Forest Education, Dehradun	Member
5.	A representative of the Ministry of Environment & Forests	Member

In case of selection of faculty for the colleges under the Directorate of Forest Education, the constitution of the committee will be as below:

<b>S. NO.</b>	<b>Designation</b>	
1.	Director, IGNFA	Chairman
2.	Director Forest Education, Dehradun	Member
3.	One Principal of one of the colleges under the DFE	Member
4.	A representative of the Ministry of Environment & Forests	Member

- (d) The recommendations of the committee will be considered by the government for making appointments of the faculty.
- (e) The performance of the faculty members will be assessed every year. In case on assessment, he or she is not found suitable for continuing in the training institution, the officer will be transferred out of the training institution/repatriated to parent cadre.
- (f) The tenure of deputation can be extended till seven years depending on the recommendations of the committee based on objective assessment on case-to-case basis.

2 These guidelines will be applicable with immediate effect. The same may kindly be brought to the notice of all the IFS officers.
